The remainder of the class fee is due the first night of the class. If you cancel within 7 days of the first day of class, your registration deposit will be refunded.

A new student planning to become a Certified Tester must complete an Ohio Department of Commerce "Backflow Tester Certification" application and mail it to the address indicated on the Ohio DOC form. We recommend that you send this application to the Ohio DOC at least 30 days before class is scheduled to begin. You can download the application from our website at www.paconplumbingschool.com.

The Ohio DOC will notify you concerning your approval to take an initial backflow tester class., The returned approved application must be submitted the first day of the PACON class.

Re-certification students will complete all re-certification requirements at the PACON class. The BF tester will submit the bf recertification application- you will receive this application in class- to the State thru the Web Portal and once it's received the State will generate an invoice of \$75.00 in which you will pay on-line.
